## **PANEL FORMAT:**

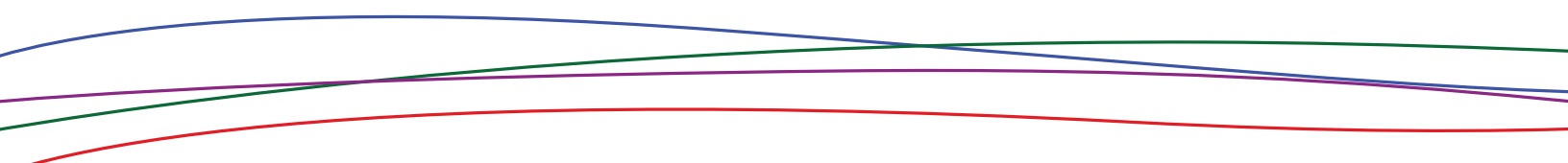

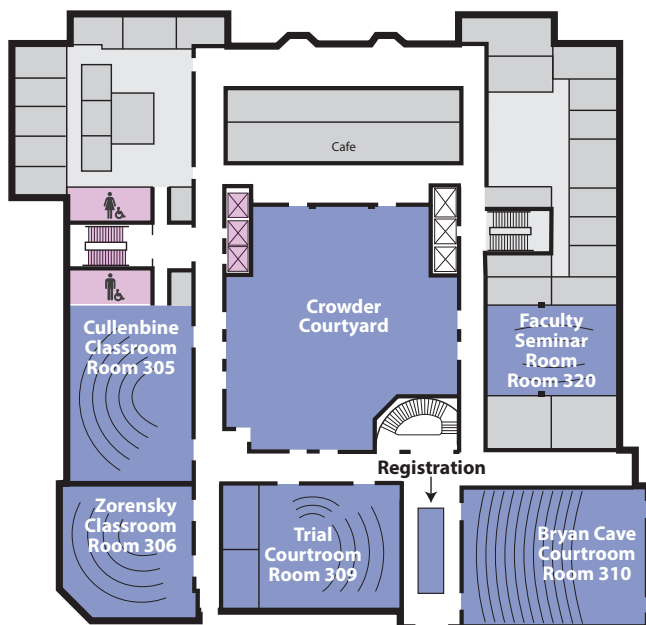

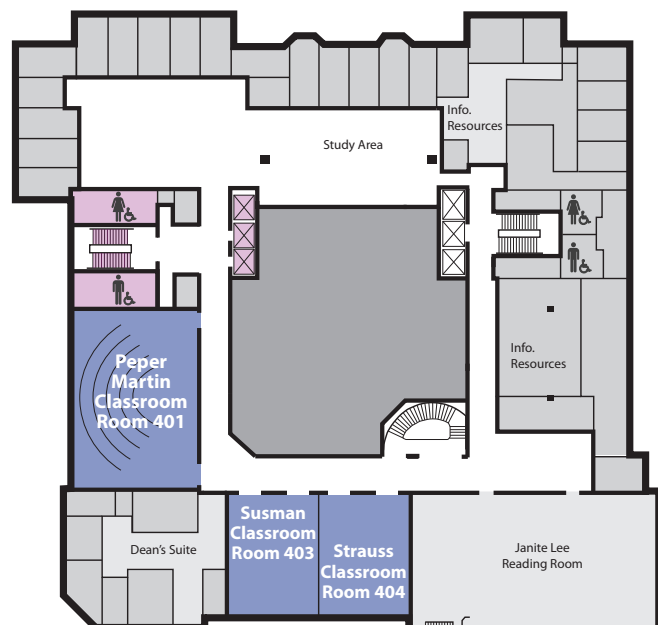

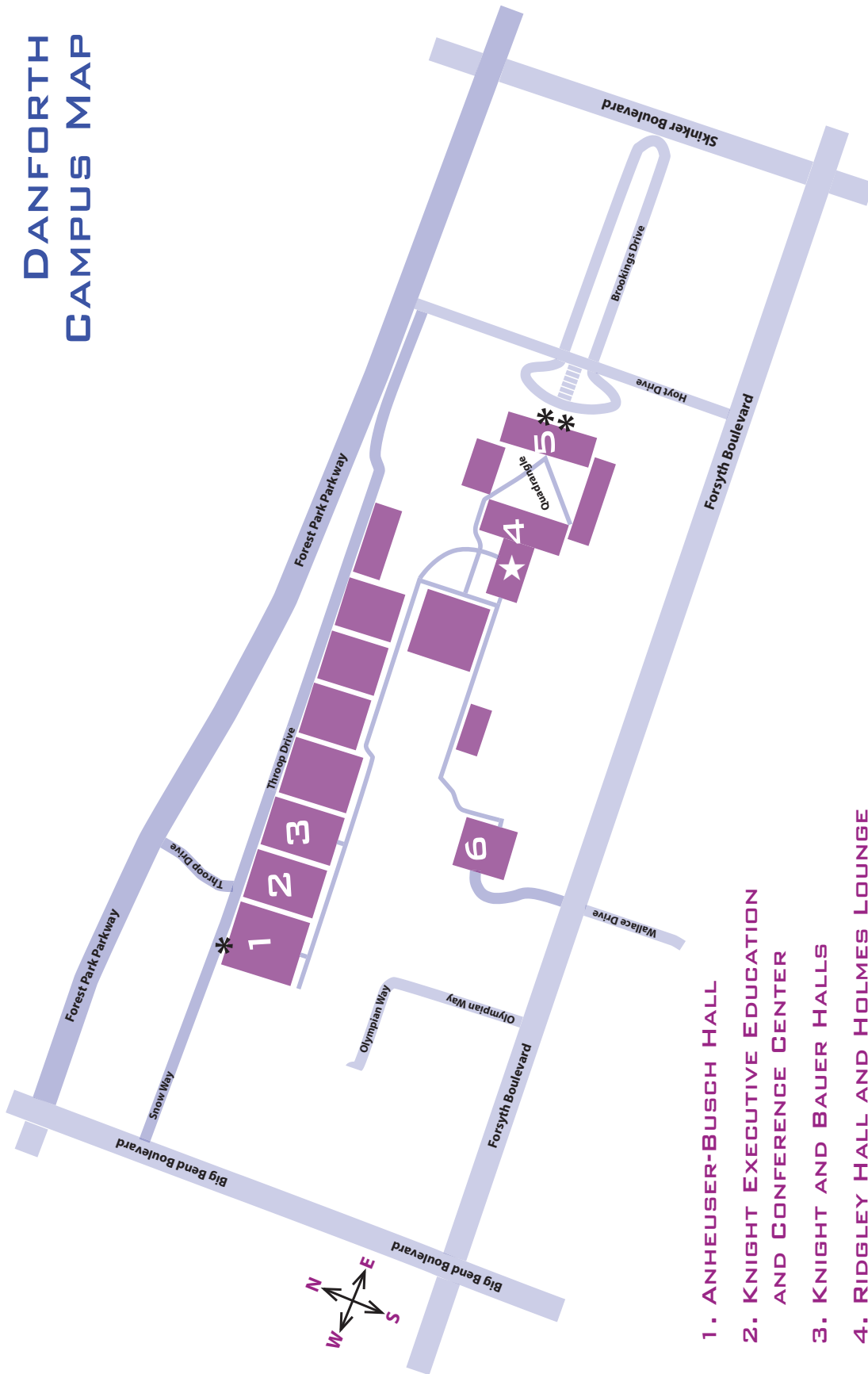

	<p>The dinner keynote address will be delivered by Richard K. Wilson, PhD., the Alan A. and Edith L. Wolff Distinguished Professor of Medicine, Professor of Genetics, Professor of Molecular Microbiology and Director of the McDonnell Genome Institute at Washington University in St. Louis. The title of his talk is “Modern Genomics and Precision Medicine.”</p> <p>Dr. Wilson is a renowned expert in molecular genetics and large-scale DNA sequence analysis and his laboratory at the Washington University School of Medicine is among the world’s leaders in genome analysis. Dr. Wilson and his colleagues sequenced the first animal genome — that of the roundworm <i>Caenorhabditis elegans</i> — and contributed substantially to the sequencing and analysis of the human genome. The McDonnell Genome Institute, founded in 1993 as the Genome Sequencing Center, played a key role in the Human Genome Project, an international effort to decode all 6 billion letters of our genetic blueprint. The institution ultimately contributed 25 percent of the sequence to the project, which was completed in 2003. Today, it is one of only three large-scale genome centers in the United States funded by the National Institutes of Health (NIH).</p> <p>More recently, Dr. Wilson’s laboratory was the first to sequence the genome of a cancer patient and discover genetic signatures relevant to the pathogenesis of the disease. Building upon this achievement, their current focus is to utilize genome sequencing and analysis technology to discover clues that will facilitate more effective diagnosis and treatment of cancer and other human diseases.</p> <p><b>PLEASE NOTE:</b> Advance registration is required.
